## WHAT IS THIS PRODUCT?

Objectives:

The objective of the Fund is to achieve long-term growth of capital and income. The Fund will primarily invest in a broadly diversified portfolio of shares (equities) issued by companies across the Asia Pacific region (primarily Asia and Australia but excluding Japan). The performance and risk of the Fund are actively managed in reference to a benchmark index, the MSCI AC Asia Pacific ex-Japan Index (the "Benchmark"). The Fund aims to outperform the Benchmark over time and does not intend to track it. The Fund will invest significantly in securities within the Benchmark but the Fund is not constrained by the Benchmark and may invest in instruments which are not included in the Benchmark. The Fund may use derivatives (an instrument that derives its value from another underlying asset) for both investment purposes and in an attempt to reduce risk, reduce costs and to generate additional income. The base currency of the Fund is U.S. Dollars. If the share class currency differs from this then its value may be affected by exchange rate movements. Hedged share classes attempt to reduce this effect but may also exclude the benefits of positive exchange rate movement. Shareholders may redeem or exchange shares on demand on any dealing day. A dealing day for this Fund is any business day for the Hong Kong Stock Exchange and for banks in either Dublin or London except 24 December. Further information is available in the Prospectus. Income generated by the Fund is distributed from the NAV (net asset value of the Fund)



## Risk indicator

## WHAT HAPPENS IF THE FUND IS UNABLE TO PAY OUT?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). If the Fund is not able to pay out what you are owed, you are not covered by any investor compensation or guarantee scheme and you may face financial loss. There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## WHAT ARE THE COSTS?

#### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold shares in the fund. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

#### We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return)
