
WHAT IS THIS PRODUCT?

- Type : The Fund is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).
- Term : The Fund has no maturity date. However, the manufacturer may decide to close the Fund under certain circumstances as set out in the prospectus.
- Objectives : The investment objective of the Fund is long-term growth of capital and income. The Fund will invest at least 80% of its assets in shares (equities) and equity related securities issued or listed in the United States, with a maximum of 25% in convertible securities and 5% in warrants. The Fund will be highly diversified and will not concentrate on any specific industry sectors. The performance and risk of the Fund are actively managed in reference to a benchmark index, the Russell 3000 Index (the Benchmark). The Fund aims to outperform the Benchmark over time and does not intend to track it. The Fund will invest significantly in securities within the Benchmark but the Fund is not constrained by the Benchmark and may invest in instruments which are not included in the Benchmark. The Fund will utilize a computer model-based strategy that selects securities by analysing several characteristics such as size, value, share price performance and share price volatility. The Fund may also use derivative instruments (an instrument that derives its value from another underlying asset) in an attempt to reduce risk, reduce costs and to generate additional income. The base currency of the Fund is U.S. Dollars. If the share class currency differs from this then its value may be affected by exchange rate movements. Hedged share classes attempt to reduce this effect but may also exclude the benefits of positive exchange rate movement. Shareholders may redeem or exchange shares on demand on any dealing day. A dealing day for this Fund is any business day for the NAV (net asset value of the Fund) for accumulating classes and distributed from the NAV for distributing classes. Further information is available in the Prospectus.
- Intended retail The Fund is intended for both retail and professional investors and is designated for those investors that have either basic, informed or advanced knowledge of relevant financial instruments. The Fund should not be utilized by an investor who cannot bear any capital losses in their portfolio.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



We have classified this product as 4 out of 7, which is **a medium** risk class. This rates the potential losses from future performance at a **medium level**, and poor market conditions could impact the capacity of the fund to pay you.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

WHAT HAPPENS IF THE FUND IS UNABLE TO PAY OUT ?

The assets of the Fund are held in safekeeping by its Depositary. In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). If the Fund is not able to pay out what you are owed, you are not covered by any investor compensation or guarantee scheme and you may face financial loss. There is also no compensation or guarantee scheme protecting you from a default of the Fund's Depositary.

WHAT ARE THE COSTS?

Cost over time

The person advising on or selling you the Fund may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold shares in the Fund. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return)
- · For the other holding periods we have assumed the Fund performs as shown in the moderate scenario
- 10,000 GBP is invested

*This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 13.49% before costs and 12.88% after costs.
